

Emerging porphyry Cu/epithermal Au-Ag system.




- 41 km<sup>2</sup> property located on the margins of one of Canada's **largest extinct volcanic complexes**.


### SATURDAY NIGHT

Midcontinent Rift (MCR) mineralized intrusion.



- Transition Metals' **PGE-Ni-Cu discovery** in 2016, hosted in similar geology to other advanced-stage MCR deposits.
- Drilling to date has expanded known mineralized envelope, measuring **~800m by 200m** (open in all directions).
- Intercepts grading **14.00m @ 1.04g/t 3E PGE (Pt+Pd+Au)**, including **1.86m @ 2.55g/t 3E PGE**.


